## Terms & Condition

**Name of work:** Proposal for conducting frequency survey for VHF communication radio signal strength in Western Railway Mumbai Division.

### SCOPE OF WORK: -


- i) The work envisages proposal for conducting frequency survey for VHF communication radio signal strength in Western Railway Mumbai Division as per Schedule of Material & Works and as per specification
- ii) If any minor material is required for above work, which is not included in the schedule of the work, the same shall be supplied and installed by the contractor in the offered cost only.

### 1.0 TERMS & CONDITION OF THE TENDER:

- 1.1 All material for executing the work is to be supplied by the contractor.
- 1.2 The rate offered by the tenderer shall be inclusive of all the taxes and shall be valid for a period of **60 days** from the date of opening of the quotation..
- 1.3 Detailed survey report of VHF set Radio signal strength in yard area and train track route are as per in prescribed format given by Railway official such that all dark zones should be highlighted for communication for given frequency band.
- 1.4 **Completion period:** The entire work shall be completed within a period of **15 Days** from the date of issue of the work order.
- 1.5 **PAYMENT TERMS:**
  - i) All payment shall be made on the basis of submission of bill invoice
  - ii) 100% Payment shall be made after successful completion of the work certified by **SSE/T/Co/MMCT.**
- 1.6 In case of extension of time for delay due to contractor, clause 17-B of IR Standard GCC (Latest) will be applicable.

### 2.0 SETTLEMENT OF DISPUTES:

- i. The disputes will be settled under the arbitration act 1996.
- ii. The successful tenderer shall put up his/their claim as per clause 43 of the General Condition of Contract during the progress of work and not after completion of the work. All such claims and disputes shall be settled promptly during the progress of the work. The final authority for giving the decision on claims and disputes put up by the contractor shall be the Sr.DSTE (Co.) Mumbai Central, Western Railway, and Mumbai only.
- iii. The provision of clause 63 and 64 to the General Condition of contract will be applicable only for settlement of claims or disputed between the parties for values less than or equal to 20% of the value of the contract. When claims or disputes are of value more than 20% of the value of the contract, provisions of clause 63 and 64 and other relevant clauses of the General Conditions of Contract will not be a remedy for settlement of such dispute.
- iv. The contractor shall not be entitled to ask for arbitration before the completion of the work assigned to him/them under this contract. The contractor shall seek reference to arbitration to settle disputes only once within the ambit of condition of 2.2 & 2.3 above.
- v. The contractor/s shall not be entitled to make any claim whatsoever against the Railway under or by virtue of or arising out of this contract, nor shall the Railway entertain or consider any such claim, if made by the contractor/s after he/they would have signed a 'No Claim Certificate' in favour of the Railway, in such form as shall be required by the Railway/s after the works are finally measured up. The contractor/s shall be debarred from disputing the correctness of the item covered by 'No Claim Certificate' or demanding a reference to arbitration, in respect thereof.
